An international transaction is classified as DCC or FCY depending on identification set by the network (VISA/Mastercard)

Transactions (Balance Enquiry, Mini Statement & PIN Change) will be free.

For transactions at Non HDFC Bank ATMs, transactions considered for charging will include both Financial (Cash Withdrawal) and Non-Financial Transactions (Balance Enquiry, Mini Statement & PIN Change).

Transactions conducted at ATMs in Mumbai, New Delhi, Chennai, Kolkata, Bengaluru and Hyderabad will be considered as Metro ATMs.
