अधिसूचना

हिमाचल प्रदेश के राज्यपाल, भारत के संविधान के अनुच्छेद 309 के परंतुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, हिमाचल प्रदेश लोक सेवा आयोग के परामर्श से, हिमाचल प्रदेश राज्य में लागू सेंट्रल सिविल सर्विसिज (लीव) रूलज़, 1972 का और संशोधन करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात् :-

- संक्षिप्त नाम और प्रारंभ। 1. (1) इन नियमों का संक्षिप्त नाम सेंट्रल सिविल सर्विसिज (लीव) हिमाचल प्रदेश संशोधन नियम, 2026 है।
(2) ये नियम दिनांक 07 अगस्त, 2024 से प्रवृत्त हुए समझे जाएंगे।

- रूल 56 का प्रतिस्थापन। 2. हिमाचल प्रदेश राज्य में लागू सेंट्रल सिविल सर्विसिज (लीव) रूलज़, 1972, के रूल 56 के स्थान पर निम्नलिखित रखा जाएगा, अर्थात् :-

- (1) During Study Leave availed of outside India, a Government servant shall draw Leave Salary equal to the pay that the Government servant drew while on duty with Government immediately before proceeding on such leave and in addition the Dearness Allowance and House Rent Allowance.
- (2) During Study Leave availed of in India, a Government servant shall draw Leave Salary equal to the pay that the Government servant drew while on duty with Government immediately before proceeding on such leave and in addition the Dearness Allowance and House Rent Allowance as admissible in accordance with the provisions of Rule 60.
- (3) Payment of leave salary at full rate under sub-rule (2) shall be subject to furnishing of a certificate by the Government servant to the effect that he is not in receipt of any scholarship, stipend, or remuneration in respect of any part-time employment.

- (4) The amount, if any, received by a Government servant during the period of Study Leave as scholarship or stipend or remuneration in respect of any part-time employment, shall be adjusted against the Leave Salary payable under this sub-rule subject to the condition that the Leave Salary shall not be reduced to an amount less than that payable as Leave Salary during half-pay leave.

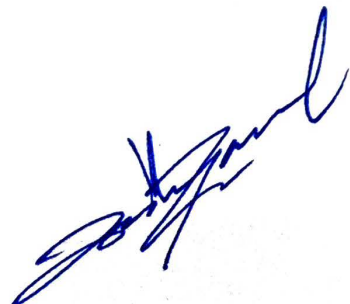

NOTIFICATION

In exercise of powers conferred by proviso to article 309 of the Constitution of India, the Governor of Himachal Pradesh in consultation with the Himachal Pradesh Public Service Commission is pleased to make the following rules, further to amend the Central Civil Services (Leave) Rules, 1972, in their application to the State of Himachal Pradesh, namely :-

Short title and commencement. 1. (1) These rules may be called the Central Civil Services (Leave) Himachal Pradesh Amendment Rules, 2026.
(2) They shall be deemed to have come into force w.e.f. 7th August, 2024.

Substitution of rule 56. 2. In the Central Civil Services (Leave) Rules, 1972, in their application to the State of Himachal Pradesh, for rule 56 the following shall be substituted, namely:-
(1) During Study Leave availed of outside India, a Government servant shall draw Leave Salary equal to the pay that the Government servant drew while on duty with Government immediately before proceeding on such leave and in addition the Dearness Allowance and House Rent Allowance.
(2) During Study Leave availed of in India, a Government servant shall draw Leave Salary equal to the pay that the Government servant drew while on duty with Government immediately before proceeding on such leave and in addition the Dearness Allowance and House Rent Allowance as admissible in accordance with the provisions of Rule 60.



- (3) Payment of leave salary at full rate under sub-rule (2) shall be subject to furnishing of a certificate by the Government servant to the effect that he is not in receipt of any scholarship, stipend, or remuneration in respect of any part-time employment.
- (4) The amount, if any, received by a Government servant during the period of Study Leave as scholarship or stipend or remuneration in respect of any part-time employment, shall be adjusted against the Leave Salary payable under this sub-rule subject to the condition that the Leave Salary shall not be reduced to an amount less than that payable as Leave Salary during half-pay leave.”.

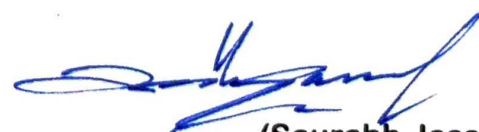
